New vehicle, equipment, and engine manufacturers seeking to import and sell their products in North America must comply with requirements set forth by regulatory agencies including the U.S. Environment Protection Agency (EPA), California Air Resources Board (CARB), and Environment Canada (EC). Specifically, these agencies require that only vehicles and equipment with certified engines can be imported unless the manufacturers utilize certain "flexibility" provisions, such as the Transition Program for Equipment Manufacturers (TPEM). Compliance with these programs is tracked through a detailed agency reporting process prior to each import, as well as on
